
1. Pursuant to section 4(d) (3), Universal Military Training and Service Act, and AFM 35-5, you have been transferred to the Air Force Reserve effective 24 April 67 and will remain assigned thereto until 17 July 69 unless sooner relieved.
(effective date of transfer)
(date of termination of obligation)

2. Since you were initially enlisted or inducted after 9 August 1955 and before reaching your 26th birthday, the law requires that you serve in a Reserve component for a period which, when added to your period of active military service, will equal a total of 6 years. Accordingly, you are transferred to the Air Force Reserve and assigned to the Obligated Reserve Section, Continental Air Command, Air Reserve Personnel Center, 3800 York Street, Denver, Colorado 80205.

3. Pending further Reserve assignment, you will report any changes in your home address to the Commander, Air Reserve Personnel Center (CAC), 3800 York Street, Denver, Colorado 80205. If you are subsequently assigned to a Reserve unit or mobilization position, you will report any changes in address to the unit of assignment. (Be sure to include your service number in any correspondence.)
