- 3. Enter the period of enlistment. (Enter whole years only.)
- 4. Enter the number of months required. (Extension must be in whole months.)
- 5. Enter a purpose as indicated in Table 13-1, AFM 35-16.
- 6. Enter the appropriate line number of the rule used (Table 13-1, AFM 35-16) to extend the applicant.
- 7. Enter the number of times that the enlistment (2, above) has been extended, including this request, i.e., if the enlistment had been extended one time previously, enter the figure "2."
- 8. Enter the number of months from the original ETS for this enlistment to include the number of months requested in this application.
