



National Police Week Closing Ceremony 412 SFS, EDWARDS AFB, CA FRIDAY MAY 17<sup>TH</sup> 2024

As nearly all of us who have ever worn the Security Forces Shield know, since 1962, May 15th has been designated as Peace Officers Memorial Day. The day is set aside to honor Federal, State, and Municipal officers who have been killed or injured in the line of duty. The week in which that day falls is designated National Police Week. Our present-day Air Force Defenders, like their civilian counterparts, take this week to recognize and honor our own fallen heroes. Edwards AFB's 412<sup>th</sup> SFS was right in step for the occasion.

Lt Col Patrick Gordon, the unit commander and his cops crafted a very fitting closing ceremony on Friday, May 17<sup>th</sup>, 2024, which was supported by wing leadership, squadron members and family, and local enforcement representatives. The base Chapel Annex was filled to capacity to include honored guests from the Jones Family, whose son sadly passed away in May 2020, in a swimming accident while assigned to their squadron.







You may ask: why is DeCubellis involved in this event? Seems eloquent guest speakers were in short supply throughout the Southland, so Lt Col Gordon reached out to AFSFA's president John Probst, who in turn contacted me. With a little arm-twisting, they convinced me to drive 3 hours to make the presentation at the Edwards event. Then I talked Mike Kennedy into joining me! If you'll continue reading, you'll see my reason went beyond having company and a navigator!



Photos and biographies of the fallen were displayed at the head of the room and, as each name was solemnly read, the assembled men and women rendered one pushup in their honor. The Los Angeles County Sheriff's bagpiper's music was a somber and touching contribution to the solemnity of this day of remembrance.



I discovered as I did homework to craft some meaningful comments, that VSPA brother Mike Kennedy had some linkage to the area and what we were commemorating. Prior to his Bien Hoa tour, he'd been assigned to nearby George AFB. While Mike was in transit in 1969, his flight chief and mentor was gunned down in a domestic dispute.

Mike later found out that TSgt Isiah Roberts' name was not included on the National Law Enforcement Officers Memorial in Washington DC, and so he took up the cause. After nearly two years of research and diligent negotiations with various officials, Kennedy accomplished his mission. TSgt Roberts, the 95th SFS's TSgt Butler (murdered in a traffic stop), and VSPA's Capitol Police Officer JJ Chestnut (lost on Jul 28,1998 in a shooting on post in the US Capital Building) were all honored in May 1999. Mike attended the "Candlelight Vigil" where each name was read, in Washington DC with TSgt Roberts' widow and her children. Like VSPA's Motto: "*We Take Care of Our Own.*"

Touching on other matters of our career field's history and heritage, I told the participants how proud we are of today's Defenders, noting they will face many challenges--- some constants and many new ones. In some ways, the "attitudes" foisted upon today's Defenders and their fellow LEOs are not a lot different from what we Vietnam veterans dealt with upon returning home from an unpopular war. Our on-going initiative to memorialize "Knife-13" was touched upon. The first of two monuments going up at the Security Forces Museum on JB Lackland will honor those 18 cops and 5 aircrew lost while supporting the recovery of the SS Mayaguez off the coast of Cambodia in 1975.

I encouraged them to be supportive of each other, to be professional at all times, and to realize that most of the public they serve appreciate and value their service and sacrifices. Mike Kennedy and I thanked them for the opportunity to join them in their closing ceremony.

In closing I left them with: "memorials are built, names are read, and words are spoken for one reason: to honor the fallen and what they stood for. It's been said that as long as the names of our fallen are spoken, they will not be forgotten."

Following the end of the ceremony, Lt Col Gordon gave us a tour of his squadron and we watched a Guardmount and had some interesting discussions and swapped coins. It was well worth the trip!

PETS ARE NOT ALLOWED! You must book early to ensure that rooms are available. DON'T WAIT! Overnight Self-Parking is available for \$20 per day. Valet Parking is available for \$39 per day. Motor Coach parking is space-available for \$65 per day.

#### ABOUT THE EARLY BIRD DISCOUNT:

The Reunion BRAT and your VSPA Board of Directors experienced severe impact on planning and preparation for prior reunions due to <u>late and incomplete registrations</u> that were received long past the deadline. The impact on the VSPA Board and Reunion Planning Committee consisted of delaying plans with the bases, obtaining authorization for base entry, and coordinating with multiple units at the bases. A variety of other problems have occurred that we had to resolve on behalf of our members by contacting them for the Reunion BRAT. We have reduced those problems significantly through the implementation of our EARLY BIRD FEE, which has been unanimously approved by our membership.

THEREFORE, THE \$25 EARLY BIRD CREDIT ON YOUR REGISTRATION WILL BE HONORED IF YOUR REGISTRATION IS POSTMARKED BY SEPTEMBER 9. FOR REGISTRATIONS POSTMARKED AFTER THAT DATE, THE REGISTRATION FEE WILL INCREASE BY \$25.

- The information that you provide on this form is critical for a successful reunion. All name and base
  information will be placed on your reunion identification badge. Guests will also receive reunion
  identification. The reunion ID will serve as your identification throughout the reunion and when you
  attend the Knife-13 Memorial Dedication at Lackland AFB.
- <u>PLEASE PRINT</u> or type all information <u>clearly</u>. Do not use abbreviations on any portion of the registration form.
- <u>RVN OR THAI BASE INFORMATION</u>: Please list only those bases where you served in Vietnam or Thailand. When listing bases, <u>do not abbreviate</u>. When listing squadrons, please indicate Air Police, Security Police, or specific detachments. The information will be used on your reunion ID.
- HOME ADDRESS and MAILING ADDRESS: for your confirmation letter. THE CONFIRMATION LETTERS WILL BE MAILED BY <u>SEPTEMBER 20, 2024.</u>
- <u>TELEPHONE AND EMAIL ADDRESS</u>: Your contact information is vital to a successful reunion. You will also receive a copy of the attendee roster upon arrival at the hotel.
- <u>NAMES OF YOUR GUESTS</u>: Please provide the first name, middle initial and last name of your guest(s) on the Registration Form. YOU MUST ALSO COMPLETE THE BASE ENTRY SECURITY FORM.
- <u>RENEWAL OF ANNUAL DUES</u>: For existing VSPA members only you can renew your dues at the time of registration if they are not current. VSPA membership must be current to attend the reunion or bring a guest. Life Members have paid their dues for life.
- <u>VSPA MEMBERSHIP</u>: If you are not a member of the Vietnam Security Police Association, please do not send \$15 with this registration form. You may join at the reunion by completing an application and providing your DD Form 214 showing service in Vietnam or Thailand as a USAF Air Policeman, Security Policeman or Augmentee. For further information on how to become a member, contact Larry Fleming (254) 396-4091.
- REUNION COST: The registration fee is \$225 per person UNLESS YOU MISS THE EARLY BIRD DEADLINE WITH A POSTMARK OF SEPTEMBER 9. The registration fee will be \$250 per person for all registrations postmarked after September 9. THIS IS CRITICAL because of the work that must be completed by the Reunion BRAT and your Board of Directors. The following work must be completed by the Reunion BRAT after registrations are received: ENTRY AUTHORIZATION LIST OF ATTENDEES MUST BE RECEIVED BY LACKLAND BY OCTOBER 1. A full audit of all names, base names, squadrons, and fees paid. The audit of names must be correct for the EAL, to print reunion ID badges, pay advance fees to the hotel and bus transportation company based upon the number of people attending the reunion. Only then can the confirmation letters be mailed to our members. All of the registration and identification information must be assembled in Registration Welcome Packages that have to be mailed in bulk to the hotel with enough time for delivery no later than Tuesday, October 8, the day before registration opens at the hotel. Shipping and delivery are very difficult to guarantee with the current delays in mail systems and shipping. Once the packages arrive at the hotel, another audit must take place so that reunion specific items may be placed in each welcome package, including reunion pins, patches, meal tickets, bus tickets, raffle information and local restaurant information. #### **STATUS REPORT**

The Vietnam Security Police Association is raising funds to deliver two long-overdue memorial monuments to recognize and honor the 18 Security Policemen and five aircrew members who were all assigned to the 56th Special Operations Wing, Nakhon Phanom, Thailand. They perished in the crash of United States Air Force Helicopter, Knife-13, on 13 May 1975 in Thailand. The monuments will be located at the Security Forces Museum at Lackland Air Force Base, Texas, and Luke Air Force Base, Arizona, the current home of the 56th Fighter Wing and the 56th Security Forces Squadron. The memorial that will be located at the Security Forces Museum will be dedicated in October, during the coming VSPA Reunion. The memorial at Luke Air Force Base will be dedicated in October of 2025 during the 30<sup>th</sup> VSPA Reunion, which will also be the 50<sup>th</sup> Anniversary of the crash of Knife-13.

A great deal of planning and fundraising has been done by the VSPA's Knife-13 Memorial Planning Committee. 12,000 pounds of black granite has been ordered for the memorial at Lackland. The foundation for the memorial is in place. The graphic design has been researched and refined to depict the faces, names and ranks of each one of our heroes who volunteered for the mission to rescue the crew of the Mayaguez. The Air Force Historical Research Agency has approved the design.

Just as the aircrew and our eighteen brother Security Policemen volunteered to rescue the captured crew of the Mayaguez, we have volunteered to care for them, to raise funds and build two memorials to preserve the honor and history of their sacrifice. The men on board Knife-13 perished in their effort to take care of their own. We need to honor and take care of our own.

The VSPA is a 501(c)(19) tax exempt organization of military war veterans who served as United States Air Force Air Policemen, Security Policemen, and Augmentees in Vietnam and Thailand. All donations to the memorials will be tax deductible for donors and **WE NEED YOUR HELP WITH FUNDARAISING.** The anticipated cost of both granite monuments has been estimated at \$100,000. Fundraising is already underway using VSPA's extensive network of Air Policemen, Security Policemen and Augmentees, retired and active-duty Security Forces Defenders, including K-9 and others, plus the Special Operations community.

The year 1969 for me was a time of growth, wonderment, hope, and fear. On July 20 Apollo 11 landed on the moon and a man stepped on another planetary body for the first time. Fifty years ago, I was twenty-one and in the third year of my USAF enlistment. Stationed at a small airbase, Binh Thuy, I had grown to adulthood through my travels and experiences in the military. After my baptism under fire and a steady diet of mortar attacks by an unseen enemy, I hoped and prayed that if I survived, I would pursue a degree in engineering.



Vietnam was never declared a war, but don't tell that to any Nam vet or the families of the 58,000-plus KIAs and the countless others wounded. The Age of Aquarius had become a distant song. The reality of war, social unrest, protest, political conniving, and government incompetence embedded itself in our hearts and minds. But this is not about that; I am merely painting the view we had from the Mekong Delta while trying to live up to the ideals of military service and fighting for a democracy. Humankind was about to realize President Kennedy's vision: *"This nation should commit itself to achieving the goal, before this decade is out, of landing a man on the moon and returning him safely to the earth."* 



At times I feared I would fly out of there not in a Freedom Bird, but in a flag-draped coffin. I dealt with this morbid possibility of my demise with an equal sense of survival and humor. I embraced a countdown of the days left in country on my short-timer's calendar.

On July 20, 1969, when I was six months into my tour with six to go—not officially a short timer yet, but not a cherry either—Apollo 11's three crewmembers were preparing to land on the moon. The snippets of reports on Armed Forces Radio and Stars and Stripes were all we had, since TVs were rare, and we slept during the day when most programming was available. For me and my fellow Security Policemen, it would be a typical day of sleeping

from 8 a.m. until maybe 3 p.m. after another long night providing security for the base perimeter, then getting up and repeating the nightly Devil Flight routine all over again.

My assignment was 15 Alpha, a 25-foot steel tower on the far end of the base runway. As I climbed up, then went in and turned to face the tiny village and the Bassac River beyond the perimeter, before me was a bright, almost-full moon in all its glory. I sat down and immediately knew that this night would be different from any other.

Apart from the fact that history was unfolding, it could have been just another night of vigilance and fear, another nocturnal passage in this exotic, beautiful, but war-torn country. While most Americans were tuned to their TVs, I settled into my post, checked and arranged my equipment, then dug into my gear for my transistor radio. I inserted the earpiece and tuned into Armed Forces Radio for the live broadcast of the lunar mission.

Although it would be hours before the descent to Tranquility Base, I was transfixed by the moon before me and probably put myself and fellow airmen at risk. As the lunar lander emerged from that last orbit around the dark





side of the moon and resumed communications, the excitement, fear of failure, and hope of success practically had me riding with them as my imagination soared.

Then, as the descent began, I vividly remember intense color as the retro rockets slowed the descent and they radioed back that they saw moon dust stirring up just before the crew counted down the last few feet to touchdown and engine shutoff. The words, *"Houston, Tranquility Base here. The Eagle has landed,"* came through the earpiece. I let out a loud "Whooowie!" America was first on the moon, and I watched—yes, watched—from halfway around the world, and there was glory, victory, and renewed hope for the genius and resourcefulness of humanity.

Just then someone called out. It was my sector K9 team. He had heard my whooping. I recounted all that had just happened and the dog handler, too, was thrilled. But I was living it and soon was right back on the moon. Luckily, Victor Charlie did not spoil this night.

At about 3 a.m. July 21 on my side of the world (3 p.m. the day before on the East Coast), the decision was made to open the hatch and climb down from the lander, which would take about six hours. I would be off duty in three and the radio battery was about dead, so the first words by Neil Armstrong after stepping off the ladder were heard by a group of us in our hooch: *"That's one small step for a man; one giant leap for mankind."* 

We were all in awe but tired and needed to rest. After that, we slept and maybe dreamt of home, family, girlfriends, and the possibilities of the future—a future that 58,281 would never realize. So yes, I remember the triumph of July 20, 1969, and for me it's inexorably linked with the tragedy of the Vietnam War.

Years later I saw the video of Apollo 11 sitting on the moon and the astronauts' walk. But the video couldn't compare to what I, while sitting in that tower with the moon aglow in a clear black sky, saw in my mind with such clarity and wonderment. As I have relived it over and over through five decades, I wouldn't trade it, not for anything.




## **Operation Cold Tar** Carl Essig, Life Member #978, Cam Ranh Bay 68-69

I was stationed at McGuire AFB, New Jersey from 1966 to Feb 1968. In Dec 67 we had a pretty good snowstorm and at the same time for some reason they started posting guards on some C-141's parked on the flight line, which was not normal, and no one could figure out why.

On 28 December 1967 I was given Flight Orders for a special airlift mission. I don't remember how I was given the assignment, but I didn't have time to let my new bride know that I would not be home on my three-day break. A Staff Sergeant and I were given flight orders as crew members and ordered to proceed "as directed" on a C-141 to perform an airlift mission with a scheduled return to McGuire on or about 28 January 1968.

We departed McGuire on our assigned C-141 and only flew a short distance and landed at a Naval Air Station near New York City. After landing we were met by Brinks Armored trucks! They proceeded to load pallets of Gold Bullion onto the aircraft, from one end to the other. According to the loadmaster, it was 36 million dollars! Once the plane was loaded, the aircraft took off and flew up over Greenland, Norway, and Sweden, then down to Mildenhall AFB in England.



I asked why we didn't fly straight across the Atlantic from New York to England. The pilot said that if the aircraft encountered a problem, it would be easier to recover the gold. They wouldn't have to fish the gold out of the ocean.

The flight crew treated both of us Security Policemen great. They invited both of us up to the cockpit, one at a time and let us sit and ask questions. I also got to see the Northern Lights from the cockpit.



I can't find any information about this operation, its name was "**Operation Cold Tar**" and there were many more flights with the same cargo. England's pound was in trouble, so the USA loaned the Gold to England, then it was returned later probably the same operation in reverse. Although I can't find any detailed information on this operation, the **C141HEAVEN** website blog contains a reference under its Tall Tales tab by a C-141 aircrew member who makes reference to flying similar missions around the time I was assigned to the mission. The blog also talks about the security being armed with Thompson's, but we were carrying our standard M-16 rifles.

Three months later I was on my way to Cam Ranh Bay, South Vietnam April 68-69.

### HYPERTENSION (HIGH BLOOD PRESSURE) UNDER THE VA PACT Act

If you submitted a claim for Hypertension and receives a 0% rating, remember that the most important part is that you are Service-Connected (SC) for this condition, which eventually, might be much more important than receiving compensation. It's all about the numbers.

# VA RATING FOR HYPERTENSION (HBP) - JANUARY 2023

The VA rates hypertension on a scale from 10% to 60% based on your **Diastolic** (bottom number) and your **Systolic** (top number). Here's the breakdown of ratings:

RATING	Diagnosis – Diastolic (bottom number) & Systolic (top number)
0%	Just for presumptive service-connected.
10%	If your bottom number is 100 - 109 or your top number is 160-199.
20%	If your bottom number is 110 - 119 or your top number is 200 plus.
40%	If your bottom number is 120 - 129.
60%	If your bottom number is 130 or higher.

If you filed a claim for HBP and received a service-connection for it, but only with a 0% compensation rating and you disagree with this rating, you should follow up with a disagreement, by submitting a VA Form 20-0995-Supplemental Claim, along with some additional/new evidence that's relevant to your case or identifying new evidence for review. If you are currently taking meds for HBP you should state that's the reason your numbers are below the VA rating scale.

Here's why a 0% rating should be more important to you. If you are married, and unfortunately, die of a Service-Connected such as, Hypertension (HBP), your spouse can put in for VA compensation. All she needs to do is submit a claim with the VA (with the assistance of a DAV CSO) along with the following document, which are:

- 1. A copy of the death certificate with either the primary or secondary cause of death stating the condition which might fall under the Agent Orange medical conditions. So, if you die of complications of HBP, she would be covered.
- 2. A copy of your marriage license and
- 3. A completed VA Form 21P-534EZ (Application for DIC, Survivors Pension and/or Accrued Benefits).

VA Form 21P-534EZ is also used for applying for a Survivors Pension, which is much different than a DIC.

I will be discussing this at our reunion to our members and the Sisterhood.

BTW – If you have rated 100% disabled by the VA for 10 or more years, it <u>does not</u> matter how you died. It does not have to be for a SC condition.

This change was suggested by members in the interest of saving time due to motions and seconds that were routinely required in the past that added unnecessary time in an already lengthy meeting.

6. APPROVAL OF THE MINUTES of the previous annual business meeting. Rather than taking the time to read them during this meeting, we published the minutes in Guardmount.

#### 7. OLD BUSINESS

#### 7.1 REUNION SITE SELECTION FOR 2025

# a. AN AMENDMENT TO THE BYLAWS AND CONSTITUTION WAS UNANIMOUSLY PREVIOUSLY APPROVED:

1. Pursuant to Article III, Section 2, Reunions, Paragraph B

"We offer strong support to all active duty and reserve members of the United States Air Force Security Forces. Therefore, our reunions can be held near a United States Air Force base with an active-duty Security Forces Squadron, or an independent destination chosen and voted on by the general membership at the annual business meeting."

- **b.** Reunion sites are selected two years in advance so that planning by the VSPA can begin early. We need to be able to adjust to events in the chosen area. If we are being hosted by a Security Forces Squadron, they can begin early and have the time necessary to adapt to active-duty operational requirements.
- c. The reunion site for this reunion in Charleston, South Carolina was selected in 2021. As in the past, the 2023 reunion will be held in October, the Wednesday through Sunday before the Columbus Day holiday (which is always the second Monday in October). The dates are October 4 8, 2023. The sites selected at our 2021 Reunion were:







- 1. Primary Site for 2023 is Eglin AFB, Destin, Florida.
- 2. Secondary Site for 2023 is Wright-Patterson AFB, Dayton, Ohio.
- **3.** Backup Site for 2023 is Joint Base Charleston, South Carolina. Final selection due to local cost concerns for Destin and Dayton associated with the economy.
- d. The site selection process for 2024 was conducted in 2022. The Reunion Dates for 2024 are October 9 13, 2024. While the off-site city was included in the reunion site selection process, the following are the results of the selection:
  - **1.** Primary Site for 2024 is Lackland Air Force Base, Texas, and the planned dedication of the Knife-13 Memorial.
  - 2. Secondary Site for 2024 is Tinker Air Force Base, Oklahoma.
- e. President Jerry Nelson explained past reunions and the bylaw requirement to choose by alternating regions in the CONUS: WEST, CENTRAL and EAST regions and **THAT WE MUST CHOOSE** A LOCATION IN THE WEST CONUS FOR 2025 because we are in the EAST REGION this year and will be in the CENTRAL REGION next year.
- **f.** President Jerry Nelson explained the potential selection of sites in the WEST REGION in accordance with the change in the BYLAWS. He also explained the modified base selection procedure where available bases were listed on a ballot that was placed in the Reunion Welcome Packets. The purpose of the ballot is to save time during the business meeting by allowing members in attendance to select their top three choices, then submit the ballot prior to the meeting so that the time devoted to site selection will be limited to the top three choices from bases and off-site city on the ballot.
- **g.** To address the amendment to the BYLAWS and Constitution, your Board of Directors conducted research to identify locations within the WEST REGION with hotels in the area that could accommodate VSPA requirements for a reunion site. The only available cost effective off-base site is SAN DIEGO.

- **8.5 MEMBERSHIP CHAIRMAN'S REPORT** by Paul Shave presented by Steve Gattis on behalf of Paul who could not attend. Paul had registered to attend the reunion but was diagnosed with a difficult and persistent kidney infection. He has served our Association as Membership Chairman for many years and has done a wonderful job. He has asked to step down in the future. We are actively looking for someone who would be interested in serving in this position. If you are interested, please contact one of our Board of Directors. Additional membership information is covered in the Web Site Report.
- **8.6 BX SALES REPORT** by Steve Gattis. The BX Managers, Van and Joyce Digby, were unable to attend the reunion due to COVID. The BX is a self-sustaining operation that buys memorabilia and wholesale prices from various vendors so that they can provide a single point of sale at significant savings for our members. Last year they sold \$7,729 in merchandise with expenses of \$5,515. They had \$17,595 on hand at the end of 2022. The Digby's provide outstanding service to our members. After the last reunion, they handled the online sales of the Knife-13 Medallions and The Pieta to raise funds for the Knife-13 Memorial Project. This year, they shipped challenge coins, Knife-13 Medallions, and the VSPA Flag with campaign streamers to us at the hotel.
- **8.7** WEB SITE REPORT Presented by Steve Gattis on behalf of Don Poss, our Director of Communications, who could not attend. Don has had three major projects among many many others that keep him busy on a daily basis when not dealing with web site maintenance, catheters, and bladder cancer. There is a consistent need to update all base histories, squadron lineage, articles, stories, and poetry to downloadable PDF files to ease the process of research and the preservation of our history. Don has developed an outstanding search engine to conduct research on the web site. The tool is available on the VSPA Home Page. Enter a subject and the engine will search all of the VSPA Web Site files. Don's most important project during the last two years has been the creation of proposed designs for the KNIFE-13 Memorials at Luke Air Force Base and the Security Forces Museum at Lackland Air Force Base which you can see in the posters on the table. His other major project has been the complete revision of the membership database so that it could be posted as a PDF file on the web site. He sent the links to all members via the email addresses that we have in our database. He specifically requested members to contact him if they found errors in the master roster or base rosters.

If you have moved, changed your email address, phone number or mailing address, please notify Don Poss of the update so that you can receive future updates and emails regarding reunions, VSPA news regarding Guardmount being posted, and other events.

The recent updates and the conversion of the membership database were completed to make it easily searchable for members who use our web site VSPA.COM. As reported last year, we received calls from a couple of members who checked their own names in the on-line VSPA membership database and discovered that they were dead. Don explained that there was an unintentional database scramble during the conversion due to a glitch in the new software. That software has been upgraded and many of the errors have been corrected. However, new errors have been discovered by members who checked their information for the first time after the data scramble. Some of the errors were the erroneous listing of career Security Policemen as Augmentees. Don and Paul Shave have been working to correct the errors but that involved over 3,000 membership records with multiple data elements within each record. The end result was the request for members to verify their data then notify Don Poss if an error had occurred...like being listed as an augmentee, or RIP – DEAD, you need to contact Don Poss so that he



can interview you over the phone to verify all of your personal information. He's more than happy to talk to you, especially the dead guys who have been resurrected.

**STEVE GATTIS** added the following to the web site report, reminding all present that our status as a Tax-Exempt Military Organization of War Veterans requires that we follow IRS Rules and Regulations regarding the prohibition of political activity in support of or against specific candidates for office. The VSPA does not pay income tax and all donations to the VSPA are tax exempt for donors. Our exempt status is the equivalent of the government and the public paying us to conduct our business on behalf of our membership. We cannot receive the benefit of tax exemption if we engage in political activity as an organization. Therefore, the VSPA and other organizations like the VVA cannot advocate for or against candidates for political office, especially during highly contested elections or the current volatile political climate. The VSPA must demonstrate compliance by removing political comments from our bulletin boards when members attempt to organize votes or begin speaking for or against candidates. Members are free to engage in whatever political activity they desire as long as it is not in conjunction with the VSPA and our tax-exempt activities which include the web site, the bulletin boards and the VSPA private group on Facebook.

- **8.8 HISTORIAN'S REPORT**: Presented by Steve Shelt. Steve provided information on the VSPA historical archives and requested that members send copies of orders for awards & decorations, especially those with multiple names. Similarly, orders for transfer often contain names and historical address information that will help identify potential members and help locate buddies. Records of both minor and major attacks are particularly helpful since many of those records are not always available. A minor attack like harassment fire is sometimes omitted from reports to higher headquarters.
- **8.9 SECURITY FORCES MUSEUM UPDATE**: Presented by Jerry Nelson, member of the Board of Directors of the Security Forces Museum Foundation.
  - **8.9.1** Shadow boxes have been completed for many displays. Weapons displays have been upgraded. Digital photos and film have been placed on a loop for continuous display. There is a new bronze dedication plaque for the museum; the old plaque will be framed for display.
  - **8.9.2** The 820th Base Defense Group at Moody AAFB donated an airborne display.
  - **8.9.3** There is a 25<sup>th</sup> Anniversary Display of the original Defensor Fortis title, logo, and organizational authorization, signed by Air Force Chief of Staff, General Fogelman.

#### 8.10 KNIFE-13 MEMORIAL.

- **8.10.1 LACKLAND AFB** By Jerry Nelson. The Enlisted Heritage Hall will pay for electrical lighting and the concrete pad for multiple memorials (three to include Knife-13) adjacent to the Security Forces Museum (opposite from the Nemo Memorial). The Security Forces Museum Foundation has pledged \$10,000 to assist with the purchase of the Knife-13 Memorial that will be located adjacent to the Security Forces Museum. Other pledges have also been made. (Final authorization has been approved by the base).
- **8.10.2 LUKE AFB** By Deke DeCubellis and Jerry Nelson Planned future meetings with the Mission Support Group and 56<sup>th</sup> Security Forces Squadron due to personnel changes at Luke AFB. We have total support from the 56<sup>th</sup> Fighter Wing Commanding General.





#### 8.10.3 FUNDRAISING FOR THE KNIFE-13 MEMORIAL.

**KNIFE-13 MEMORIAL MEDALLION** - Steve Gattis reported the first 300 Memorial Medallions have all been sold. We ordered an additional 500 medallions that have been selling well. Medallions and The Pieta are being sold through the BX online store. Advertising throughout the Defender Nation has started with our flyer being published (at no charge) by the Air Force Security Forces Association in their DEFENDER NEWS publication every other month. The medallions and The Pieta are also being advertised on Facebook and in Guardmount.

Steve Gattis traveled to the NKP Reunion in Charleston, South Carolina in April of this year. He made a presentation to all reunion attendees and sold approximately \$2,000 in medallions. He received additional cash donations. He donated his airfare, car rental and hotel expenses. Steve Gattis, Jerry Nelson, and Bill Cummings traveled to Moody AFB, Valdosta, Georgia to attend the Safeside Reunion. Steve Gattis made a presentation to the 820th Base Defense Group and they sold medallions, raising another \$2500. They donated their airfare, car rental and hotel expenses.

Jerry Nelson has planned several fundraising contacts and potential public appearances to raise awareness of Knife-13 and planned memorials.

**THE PIETA LITHOGRAPH**: Deke DeCubellis reported that the lithograph of The Pieta was being sold for \$25 through the BX. Several of the lithographs are here at this reunion and available for sale.

**DISCUSSION**: Announcement of the Knife-13 Memorials and sales of the medallion and Pieta in other organizations is continuing. We have flyers and the VSPA Talking Paper available to our members to go to the Veterans organizations in their communities. Advertising will continue throughout the Defender Nation through the Air Force Security Forces Association magazine and the Internet.

**8.11 SAFESIDE LIAISON REPORT**: Presented by Dave Pierson. The Safeside Reunion at Moody AFB was held APRIL 17 thru 20, 2023. A SAFESIDE Memorial Bench was dedicated at Moody AFB during the Safeside reunion. The bench is similar to our VSPA and SAFESIDE benches at the Air Force Museum at Wright-Patterson AFB in Dayton, Ohio. VSPA and SAFESIDE members in this room contributed to the new bench and attended the dedication ceremony.

#### 8.12 SERVICE OFFICER'S REPORT

**JAIME LLERAS** was unable to attend due to his wife's diagnosis with cancer and the urgent need to start chemo last Monday. He sent the following information in addition to arranging for the DAV guest speaker for this meeting.

As part of the PACT ACT which the President signed in early August of 2022, there are two new Agent Orange presumptive conditions added to the list, which can affect you:

- High blood pressure (also called hypertension)
- Monoclonal gammopathy of undetermined significance (MGUS)



**MGUS** usually causes no problems. But **sometimes it can progress to more serious diseases**, **including some forms of blood cancer**. If you have high amounts of this protein in your blood, it's important to have regular checkups so that you can get earlier treatment if it does progress.

If you think you're eligible for VA health care and benefits, we encourage you to apply now.

There added FIVE NEW AGENT ORANGE PRESUMPTIVE LOCATIONS under the PACT ACT

- Any U.S. or Royal Thai military base in Thailand from January 9, 1962, through June 30, 1976
- Laos from December 1, 1965, through September 30, 1969
- Cambodia at Mimot or Krek, Kampong Cham Province from April 16, 1969, through April 30, 1969
- Guam or American Samoa or in the territorial waters off of Guam or American Samoa from January 9, 1962, through July 30, 1980
- Johnston Atoll or on a ship that called at Johnston Atoll from January 1, 1972, through September 30, 1977

If you served on active duty in any of these locations, the VA will automatically assume (or "presume") that you had exposure to Agent Orange.

You should, at the very least, submit an Intent to File From (VA Form 21-0966). This will tell the VA that you plan to submit a claim, but you don't know for what or when. When you submit the Intent to File form, the VA gives you 365 days to submit your claim along with the necessary evidence. If and when they approve, or award compensation for your claim, the pay will be backdated to the date on your Intent to File form.

Many of us have high blood pressure, also known as hypertension, but have never been able to claim it as a disability - now we can and should due to the Pact Act!

#### 8.13 HEALTH SURVEY BY 2<sup>ND</sup> VICE PRESIDENT DEKE DECUBELLIS

An initial review of the anonymous data submitted by 65 members via mail and at the last reunion indicates a trend where members have health issues that are presumptive, automatic approvals for Agent Orange related VA Disability Compensation based upon a medical diagnosis. However, they are not receiving VA Compensation. One of those conditions is hypothyroidism. Another is diabetes with neuropathy.

Some members reported Peripheral Neuropathy related to dioxin but not related to diabetes. Other conditions reported were PTSD and Sleep Apnea. The bottom line is that conditions change and more of those conditions are being approved by the VA due to the PACT Act. File your claim to establish your date for compensation. Even if they reject you, they may authorize your claim in the future. That specifically happened with bladder cancer which is now an approved Agent Orange related Cancer. They will pay retroactively back to the date of your initial filing. A copy of the report is attached to the file.



I just watched a documentary about a 2015 kidnapping case in Vallejo, California. In summation, the victim and his girlfriend were home at o-dark-thirty when he was hog-tied and she was allegedly snatched. The story he gave responding Vallejo PD would have been hard to swallow in the most gullible of enforcement agencies and the case got nicknamed Gone Girl.

Yet the end result was their story was true! Vallejo PD and the FBI, fueled by the Bay Area media and politics, caused this couple a ton of grief until another Alameda County agency investigating similar assaults and attempted kidnappings found the missing link that cleared them both! That female officer was responsible for putting the prison suit on a former Marine who was also a disbarred attorney. The guy got 40 years of bubba time and the Vallejo PD (City of Vallejo) had to pony up \$2.5M in damages to these verified victims (this is the same City that declared bankruptcy in 2009 but that's another story).

What came up in this documentary was a comment by someone in the law enforcement community that implies there are women out there (and rarely even men), that seek the attention of law enforcement by staging such events to garner attention for various psychological gratification. Perhaps this mindset is what tainted the Vallejo detective and his department AND the FBI agent that administered a polygraph on the male victim (and was tainted because he'd dated a woman involved in that case!). A link is provided at the end of this piece should you be more curious about the details of that case.

But on to my own personal vignette. In my early USAF career (1969-73) I served in Vietnam plus two tours in law enforcement on Hamilton AFB, Novato California. The event took place in late summer '71 in the Wherry Housing area near the North Gate and Commissary for those who remember this Garden Spot of the West. It was comprised of WW II-era substandard housing units that were home to many married airmen who could afford nothing better and earned the quaint and most appropriate nickname of Splinter City.

I was dispatched on an unspecified call for service at about 1145, arriving at the quarters to find a frenzied A1C at the door of his humble two-story abode. As he ushered me inside demanding I come upstairs with him, I noted nothing unusual about the entryway, the living room and adjacent kitchen. I kept asking him why he called and what was his issue as we mounted the stairs. Well, the answer became very apparent once we entered the secondfloor bedroom.

His young wife, sans all clothing, was spread-eagled on the bed with both feet and one wrist tied to the bedposts and it appeared her other wrist was secured by a clock radio power chord. I, of course, immediately asked if she was hurt or needed medical attention. Except for the fastenings, she appeared uninjured and the room showed no sign of a struggle. She said she was unharmed but began to tell me someone had broken in and attempted to assault her. The unidentified "perp" quickly departed when he heard her husband entering the quarters for lunch. She wasn't at all upset by the commotion this event was causing for her husband and me. I asked her husband to fetch a clean sheet or big towel to cover his wife but to not to touch anything to preserve potential evidence. I used his house phone to call the desk sergeant and have our SP Investigator with the alert photographer and the OSI summoned ASAP.

After the airman's wife was covered by him, I continued to look about the room and my attention was drawn back to that clock radio fastening her wrist. The chord was twirled around it, unlike the other three appendages. I





could envision the lady tying her feet and one wrist then, swinging the chord on her remaining wrist to give the appearance that someone else did it.

I began to suspect this being the Noon(er) Hour, she had possibly staged this scenery for the benefit of her husband, but he freaked when he saw what I saw, and called the cops. As I asked more questions like having her describe the bad guy so we could begin a search, she became evasive. Then the OSI arrived with two of their finest and I took the airman downstairs for minute as they took over. I asked the airman about his typical lunch time activities, surmising they might involve more than a chicken salad sandwich and a Coke from time to time. He flushed, stuttered, and then clammed up. I had him sit in his living room and filled in an OSI guy about my suspicions. He agreed but had the alert photographer take detailed but respectful photos before detaching the lady from her bindings. She was then transported by ambulance to the USAF Hospital for a check-up.

Subsequent investigation by the OSI with some interviews and a few tips from this airman's neighbors, confirmed our suspicions. This couple was a froggy recently-wedded pair. They were known to periodically "entertain" their neighbors with sound effects of their affection for each other through the thin Splinter City apartment walls and summer "air conditioning" from open windows. The wife eventually confessed to OSI she had dreamed up this scenario to spice up her airman's noon time lunchbreak. The incident resulted in their being ordered to live off base.

As for me, it was just another normal day on patrol plus another missed lunch while doing the Incident/Complaint Report. My guess is it was the same for the OSI, the alert photographer, the incident airman's First Sergeant, and probably the medics at the hospital. Bottom line is things are not always what they seem! Like Sgt Friday usta say: "Just the facts, M'am, just the facts!" One must not jump to conclusions in this line of work. Check out the link article or watch it on Netflix.
