- Thursday, October 5: Optional Tour of the Charleston Tea Garden, a Factory Tour and tram tour of the Tea Plantation, PLUS a visit to the Charleston Market Specialty Shops. 50 people maximum. There will be time for lunch on your own at the Specialty Shops, but you should eat your buffet breakfast.
- Friday, October 6: Buffet breakfast. 1300 Presentation by the 628th Security Forces Squadron <u>at our</u> <u>hotel</u>. Dinner and evening are open for squadron and base dinners or gatherings.
- Saturday Morning, October 7: Breakfast buffet before the VSPA Business Meeting. Afternoon open.
- Saturday Morning, October 7: Breakfast buffet before the VSPA Sisterhood gathering of wives and companions. Afternoon open.
- Saturday Evening, October 7: Banquet dinner with awards and raffle.

Our hotel has been inspected by our VSPA Life Member Gary Jones who has inspected our hotels in the past. He knows exactly what we need. His inspection was highly detailed, including contract space verifications. His report was OUTSTANDING!

We have spoken with many of our members regarding fatigue and the length of time for our tours. Members who attended previous reunions expressed concern regarding early start times, as well as fatigue and the extended days while on base. More and more of our members have difficulty walking; however, some walking may be required for the optional tours. Our planning for events will reduce walking time significantly. Our goal is to provide an opportunity for a reunion with less physical demands and more time to visit with each other in the Hospitality Room.

The REGISTRATION FEE will be \$184 per person. Our economy has been very difficult for all of us. However, for comparison purposes, the registration fees for our last three reunions were: Washington, D.C. \$210; Colorado Springs \$190; Phoenix \$210. We always work hard to control cost and sincerely hope that the registration fee is not something that will impact your ability to attend our reunion. The registration fee includes an EARLY BIRD CREDIT of \$25 for those who have a registration postmarked by <u>September 5</u>.

The Reunion BRAT and your VSPA Board of Directors experienced severe impact on planning and preparation FOR THE 2019 REUNION due to <u>late and incomplete registrations</u> that were received long past the deadline.

The impact on the VSPA Board and Reunion Planning Committee consisted of delaying plans with the base, including the meal at the base, working with outside entities who had approval authority over our ability to visit the U.S. Capitol, Arlington National Cemetery, and multiple units at Joint Base Andrews. A variety of other problems occurred that we had to resolve on behalf of our members by contacting them for the Reunion BRAT. The same issues applied to Colorado Springs and Phoenix but were significantly reduced through the implementation of our EARLY BIRD FEE, which will also be applied this year as unanimously approved by our membership.

THEREFORE, THE \$25 EARLY BIRD CREDIT ON YOUR REGISTRATION WILL BE HONORED IF YOUR REGISTRATION IS POSTMARKED <u>BY SEPTEMBER 5</u>. FOR REGISTRATIONS POSTMARKED AFTER THAT DATE, THE REGISTRATION FEE WILL INCREASE BY \$25.

We have had a huge response to our warning that rooms would sell fast at our reunion host hotel, The Crowne Plaza Charleston. Many of you responded immediately. Some missed the opportunity and discovered that the hotel was sold out. Please take advantage of the 30 additional rooms at area hotels.

INSTRUCTIONS FOR COMPLETING THE REGISTRATION FORMS

- 1. The information that you provide on this form is critical for a successful reunion. All name and base information will be placed on your reunion identification badge. Guests will also receive reunion identification. The reunion ID will serve as your identification throughout the reunion.
- 2. <u>PLEASE PRINT</u> or type all information <u>clearly</u>. Do not use abbreviations on any portion of the registration form.
- **3.** <u>RVN OR THAI BASE INFORMATION</u>: Please list only those bases where you served in Vietnam or Thailand. When listing bases, <u>do not abbreviate</u>. When listing squadrons, please indicate Air Police, Security Police, or specific detachments. The information will be used on your reunion ID.
- 4. <u>HOME ADDRESS and MAILING ADDRESS</u>: for your confirmation letter. THE CONFIRMATION LETTERS WILL BE MAILED BY <u>SEPTEMBER 15, 2023</u>.
- 5. <u>TELEPHONE AND EMAIL ADDRESS</u>: Your contact information is vital to a successful reunion. You will also receive a copy of the attendee roster upon arrival at the hotel.
- 6. <u>NAMES OF YOUR GUESTS</u>: Please provide the first name, middle initial and last name of your guest(s) on the Registration Form.
- 7. <u>RENEWAL OF ANNUAL DUES</u>: <u>For existing VSPA members only</u> you can renew your dues at the time of registration if they are not current. VSPA membership must be current to attend the reunion or bring a guest. Life Members have paid their dues for life.
- 8. <u>VSPA MEMBERSHIP</u>: If you are not a member of the Vietnam Security Police Association, please do not send \$15 with this registration form. For information on how to become a member, contact Paul Shave at 505-831-9401 or email him: <u>Paul_Shave@hotmail.com</u>. You will have to submit a completed application form and a DD-214 showing service in the USAF as an Air Policeman, Security Policeman or an Augmentee in Vietnam or Thailand 1958 to 1976, and a discharge under honorable conditions.
- 9. <u>REUNION COST</u>: The registration fee is \$184_per person <u>UNLESS YOU MISS THE EARLY BIRD</u> <u>DEADLINE WITH A POSTMARK OF SEPTEMBER 5</u>. The registration fee will be \$209 per person for all registrations postmarked after September 5. THIS IS CRITICAL because of the work that must be completed by the Reunion BRAT and your Board of Directors. The following work must be completed by the Reunion BRAT after registrations are received: A full audit of all names, base names, squadrons, and fees paid. The audit of names must be correct in order to print reunion ID badges, pay advance fees to the hotel and bus transportation company based upon the number of people attending the reunion. Only then can the confirmation letters be mailed to our members. All of the registration and identification information must be assembled in Registration Welcome Packages that have to be mailed in bulk to the hotel. Shipping and delivery are very difficult to guarantee with the current delays in mail systems and shipping. Once the packages arrive at the hotel, another audit must take place so that reunion specific items may be placed in each welcome package, including reunion pins, patches, meal tickets, bus tickets, raffle information and local restaurant information. PLEASE DON'T DELAY</u>.
- 10. KNIFE-13 MEMORIAL T-SHIRTS: We are raising funds to build two memorials for the 18 Security Policemen and five crew members who perished in the crash of their helicopter, KNIFE-13, on May 13, 1975, while enroute to the Mayaguez Rescue Staging Area. They were all assigned to the 56th Special Operations Wing at Nakhon Phanom RTAFB, Thailand.



2023 ELECTION OF VSPA OFFICERS CALL FOR BIOS AND PHOTOS

The VSPA's By-Laws call for elections of officers every two years, with all current members being given an opportunity to vote. Current members may vote in person by attending the business meeting at the annual reunion, or by mailing in a written ballot, which will be printed in the next issue of Guardmount. Each member may submit only one ballot. There are six positions up for election: President, Vice President, Second Vice President, Secretary, Treasurer and Historian. The other positions on our board of directors (President Emeritus, Past President and Communications Director) are permanent positions as recognized by our Constitution and By-Laws. All other positions in the VSPA are staff positions appointed by the president and board based upon expertise and willingness to serve the members of the VSPA. Elected officers will be confirmed and installed after the voting is completed at the reunion in October. The term of office of all positions is two years. The positions do not receive a salary and are entirely on a volunteer basis.

VSPA members have until **August 5**, 2023, to declare their intention to run for an elected VSPA position and must submit a bio and photo for publication in Guardmount. Each person who runs must have been a regular member or life member in good standing for at least two years prior to the election. Board members must have the ability to attend future business meetings that are held at our annual reunions. They must communicate via the Internet and by phone on a regular basis and must make the commitment to provide the time necessary to serve in the position - none of these are ceremonial positions.

If you want to run for an office on the VSPA Board of Directors, you'll need to submit a photo and one-page biography. Send your bio and photo to VSPA's Guardmount Editor, Mike Kennedy, electronically (mike3sps@verizon.net) or by surface mail (14766 Foxfield Lane, Fontana, CA 92336) soon enough so that he receives your information by **August 5, 2023**. The bios and the 2023 Election Ballot appear later in this issue of Guardmount.

The duties of the elected board positions below are from the VSPA By-Laws:

PRESIDENT - The duties of the President shall include, but not be limited to:

- A. Act as Chief Executive Officer and Chairman of the Board of Directors.
- **B**. Cause to be called all regular and special meetings of the organization.
- C. Preside over all regular and special meetings of the organization.
- **D**. Enforce the Constitution and By-Laws.
- E. Direct and supervise the operation of the organization.
- F. Prepare and present the Board of Directors Annual Report at the annual business meeting.
- G. Coordinate the confirmation of all appointed staff members with the Board of Directors.
- **H**. Keep a current folder that includes all official correspondence, records, and official materials assigned to his care and turn over the folder to his successor.
- I. Be an ex-officio member of all committees, except the "Nominations Committee."

VICE PRESIDENT and **SECOND VICE PRESIDENT** - The duties of the Vice President and the Second Vice President shall include, but not be limited to:

V S P A



- A. Assist the President in the discharge of his duties.
- **B**. Assume the duties of the President in the event of his absence, illness, or call to eternal Guardmount.

- C. Execute the powers and authority of the President, when required, in the absence of the President.
- **D**. Serve as elected members of the Board of Directors.
- E. Serve as Chairman and member of the Public Relations Committee if a committee is necessary.
- F. Serve as a member of the Scholarship Committee.
- G. Prepare and present annual reports relative to the operation of their respective office at the annual business meeting.
- **H**. Keep a current folder that includes all official correspondence, records, and official materials assigned to their care and turn over the folder to his successor.
- I. The Second Vice President shall provide oversight for all record keeping activities and assist the President by maintaining hard copy records when necessary.

SECRETARY - The duties of the Secretary shall include, but not be limited to:

- A. Officiate when required in the absence of the President and Vice President.
- B. Serve as an elected member of the Board of Directors.
- C. Serve as a member of the Membership Committee.
- **D**. Be the clerk of the organization.
- **E**. Be the custodian of all business-related non-financial records and materials, with the exception of: those records which are created and maintained by the VSPA Historian, the VSPA Membership Chairman, the VSPA Treasurer and VSPA Communications Director Don L. Poss; or those records which are required for performance of the duties of the registered agent and liaison with VSPA's tax accountant and tax attorney. All such records shall remain property of the organization.
- **F**. Take minutes and keep permanent records of the proceedings of all annual Business Meetings and meetings of the Board of Directors.
- G. Prepare and distribute election ballots, if necessary and as required.
- **H**. Ensure that only members in good standing vote on organizational business. The Secretary will be assisted by the Membership Chairman and the Sergeant-at-Arms.
- I. Serve as official organization correspondent.
- J. Keep a current folder that includes all official correspondence, records, and official materials assigned to his care and turn over the folder to his successor.

TREASURER - The duties of the Treasurer shall include, but not be limited to:

- A. Serve as an elected member of the Board of Directors.
- B. Act as Chairman of the Ways and Means Committee if the committee is necessary.

Life Member #347; Bien Hoa 1970-71

Those of you who attended the San Antonio Reunion and the DC Reunion where VSPA marched, may remember a Bien Hoa member Bruce Nelson. Those of you who attended our reunion in Phoenix last year might remember that he was not present as Bruce died from complications from pneumonia and Covid that week.

A few words about Bruce. He and I served at Hamilton AFB while the non-identical twins Sgts Steve Gattis and Larry Fleming were regaling us newly assigned airmen with their tales of life in the 'Nam. Bruce and I made later the trip in 70-71 and returned to Hamilton after the twins had trashed the place. We finished our enlistments and Bruce went to Cal State San Luis Obispo, became an LA Unified School Teacher, married/amicably divorced, and later retired to Phoenix where his sole immediate living relative sister lived. His sister divorced, died of cancer, and Bruce fell on difficult times. Through our efforts we helped Bruce through the VA maze to get him 100% disabled (severe PTSD etc.) and helped him gain residency at the CA State Veterans Home in Napa CA where he spent his final years.



When he moved to Napa, he had to complete a Care Directive designating someone to act on his behalf should he be unable to do so. I got the nod along with his sister's best friend Claudia in Phoenix. When he was hospitalized just before the reunion, the hospital called me and I was asked to call the shots if he couldn't. The first night of the reunion, the ICU nurse called to tell me he agreed to go on a ventilator. I asked to speak with him and we talked a few minutes and said I'd catch him on the rebound, which he acknowledged with a whispered yes. I was later contacted to be advised the doctor believed the vent had done all it could do and recommended removal with palliative care to which I agreed knowing Bruce's wishes. He peacefully passed away 5 hours later.







But like Paul Harvey said, here's the rest of the story. After he passed, I figured my duties as a Care Directive guy were over but yea verily, there was more. The final arrangements were deferred to me by the Vets Home and the funeral home director. He'd chosen cremation but was also an organ donor. I spent 4-5 hours on the phone with those folks to ensure that happened. Next was the issue of where his remains would go. Bruce had told me last August that he was getting tired of the State Home, so I figured he did not want to reside in their Columbarium. With some negotiating, I convinced the funeral director and Riverside National Cemetery to accept his remains. I thought since he lived in So Cal most of his life, that we had members living nearby, and that RNC was a top-notch operation, that this would work out.

The funeral director and I arranged his ceremony with full military honors attended by Lu and I, Don Poss, Mike Kennedy and several others plus the added benefit of a Missing Man Military Flyover by vintage aircraft that coincidently were in the vicinity. A fitting send-off for our brother. Last of all I picked a phrase to appear on the name plate affixed to his place on the Columbarium wall.

Bruce and I were part of each other's lives for half a century. These things we do because we do take care of our own.

This change was suggested by members in the interest of saving time due to motions and seconds that were routinely required in the past that added unnecessary time in an already lengthy meeting.

6. APPROVAL OF THE MINUTES of the previous annual business meeting. Rather than taking the time to read them during this meeting, we published the minutes in Guardmount.

7. OLD BUSINESS

7.1 REUNION SITE SELECTION FOR 2024



a. AN AMENDMENT TO THE BYLAWS AND CONSTITUTION WAS UNANIMOUSLY APPROVED LAST YEAR:

1. Pursuant to Article III, Section 2, Reunions, Paragraph B

"We offer strong support to all active duty and reserve members of the United States Air Force Security Forces. Therefore our reunions can be held near a United States Air Force base with an active duty Security Forces Squadron, or an independent destination chosen and voted on by the general membership at the annual business meeting."

- **b.** Reunion sites are selected two years in advance so that planning by the VSPA can begin early. We need to be able to adjust to events in the chosen area. If we are being hosted by a Security Forces Squadron, they can begin early and have the time necessary to adapt to active-duty operational requirements.
- **c.** The reunion site for this reunion in Phoenix, Arizona was selected in 2019 and postponed to 2022 due to the COVID-19 Pandemic in 2020.
- d. As in the past, the 2023 reunion will be held in October, the Wednesday through Sunday before the Columbus Day holiday (which is always the second Monday in October). The dates are October 4 8, 2023. The sites selected at our 2021 Reunion were:
 - 1. Primary Site for 2023 is Eglin AFB, Destin, Florida.
 - 2. Secondary Site for 2023 is Wright-Patterson AFB, Ohio.
 - 3. Backup Site for 2023 is Joint Base Charleston, South Carolina.
- e. The site selection process for **2024** will be conducted by VSPA President Jerry Nelson, 2nd Vice President Deke DeCubellis, and assisting Board Members.
- f. President Jerry Nelson explained past reunions and the bylaw requirement to choose by alternating regions in the CONUS: WEST, CENTRAL and EAST regions and THAT WE MUST CHOOSE A LOCATION IN THE CENTRAL CONUS FOR 2024 because we are in the WEST REGION this year and will be in the EAST REGION next year.
- **g.** President Jerry Nelson explained the potential selection of sites in the CENTRAL REGION in accordance with the change in the BYLAWS. He also explained the modified base selection procedure where available bases were listed on a ballot that was placed in the Reunion Welcome Packets. The purpose of the ballot is to save time during the business meeting by allowing members in attendance to select their top three choices, then submit the ballot prior to the meeting so that the time devoted to site selection will be limited to the top three choices from the 15 bases and off-site city on the ballot.
- **h.** To address the amendment to the BYLAWS and Constitution, your Board of Directors conducted research to identify locations within the CENTRAL REGION with hotels in the area that could accommodate VSPA requirements for a reunion site. The only available off-base site is New Orleans. Branson, Missouri did not meet those requirements.
- i. The Base Selection Ballot is shown below:

Base Selection Ballots will be collected in the HOSPITALITY ROOM and picked up ON FRIDAY AT 2100 HOURS. - **8.5 MEMBERSHIP CHAIRMAN'S REPORT** by Paul Shave. Report attached to the file copy of the minutes.
- **8.6 BX SALES REPORT** by Steve Gattis. The Van and Joyce Digby were unable to attend the reunion this year. The BX is a self-sustaining operation that buys memorabilia and wholesale prices from various vendors so that they can provide a single point of sale at significant savings for our members. Last year they sold \$7,810 in merchandise with expenses of \$7367. They had \$15,086 on hand at the end of 2021. The Digby's provide outstanding service to our members. After this reunion, they will also be handling the online sales of the Knife-13 Medallions and The Pieta to raise funds for the Knife-13 Memorial Project.
- **8.7** WEB SITE REPORT BY LARRY POSS, HOST OF OUR VSPA SERVERS. He is providing the report for his brother, Don Poss our Director of Communications, who could not attend. Larry presented information on the need to update all base histories, squadron lineage, articles, stories, and poetry to downloadable PDF files to ease the process of research and the preservation of our history. Don's most important project this year has been the creation of proposed designs for the KNIFE -13 Memorials at Luke Air Force Base and the Security Forces Museum at Lackland Air Force Base which you will hear more about shortly.

STEVE GATTIS – Presented information on recent updates and the conversion of the membership database to make it easily searchable for members who use our web site VSPA.COM. Steve reported that in January of this year, we received calls from a couple of members who checked their own names in the on-line VSPA membership database and discovered that they were dead. Don explained that there was an unintentional database scramble during the conversion due to a glitch in the new software. Don and Paul Shave have been working to correct the errors that occurred due to the scrambling of data. It should now be working correctly. However, if you need to report a change of address, change of phone number, or you have a problem with your information in our database... like being dead and would like to be listed among the living, please contact our Membership Chairman, Paul Shave so that he can update your record.

STEVE GATTIS added the following to the web site report, reminding all present that our status as a Tax Exempt Military Organization of War Veterans requires that we follow IRS Rules and Regulations regarding the prohibition of political activity in support of or against specific candidates for office. The VSPA does not pay income tax and all donations to the VSPA are tax exempt for donors. Our exempt status is the equivalent of the government and the public paying us to conduct our business on behalf of our membership. We cannot receive the benefit of tax exemption if we engage in political activity as an organization. Therefore, the VSPA and other organizations like the VVA cannot advocate for or against candidates for political office, especially during highly contested elections or the current volatile political climate. The VSPA must demonstrate compliance by removing political comments from our bulletin boards when members attempt to organize votes or begin speaking for or against candidates. Members are free to engage in whatever political activity they desire as long as it is not in





conjunction with the VSPA and our tax-exempt activities which include the web site, the bulletin boards and the VSPA private group on Facebook.

- **8.8 HISTORIAN'S REPORT**: Presented by Steve Shelt. Information and resources have been indexed to provide excellent research for filing claims with the VA. Please submit rosters, orders, and reports for our historical archives.
- **8.9 SECURITY FORCES MUSEUM UPDATE**: Presented by Jerry Nelson, member of the Board of Directors of the Security Forces Museum Foundation.
 - **8.9a** Jerry presented information regarding the Museum Foundation's efforts to upgrade displays in various area of the museum, including complete parachute rigging recently obtained from the Safeside squadrons at Moody Air Force Base.
 - **8.9b** The museum has expended a great deal of money for new display cases. They are continuing to replace and remodel various portions of the Southeast Asia Section. The Safeside Section has been completed with original artifacts. Tim Waage has donated an Elite Guard Guidon to be placed in an updated Elite Guard Section in the museum. VSPA photos were donated for the 37th Cobra Flight at Phu Cat. Extensive historical information for the 56th Security Police Squadron while at Nakhon Phanom, Thailand was received from Mary Ann Heubusch, the wife of deceased Colonel Charles Heubusch, by Jerry Nelson with copies forwarded to the 56th Security Forces Squadron at Luke Air Force Base for their heritage room.
 - **8.9c** NAME CHANGE: The name of the Security Forces Museum Annex will revert to the Security Forces Museum, deleting the term "Annex" from the title.
 - **8.9d DEFENSOR FORTIS**: The original documents approving DEFENSOR FORTIS and the original patch authorization from the Institute of Heraldry for implementation Air Force-wide, including original signatures by the Air Force Chief of Staff, General Ronald Fogelman, were presented to the Security Forces Museum.

8.9e KNIFE-13 MEMORIAL PROJECT

- 1. LACKLAND AFB By Jerry Nelson. The memorial location adjacent to the Security Forces Museum has been approved. Preliminary designs are in process along with the development of a Talking Paper.
- LUKE AFB By Deke DeCubellis and Jerry Nelson Members of the VSPA Board met with the 56th Mission Support Group and 56th Security Forces Squadron during this reunion to discuss the design concept and placement of the proposed Knife-13 Memorial. The design concept was approved. The acting commander of the Mission Support Group stated that the commanding general of the 56th Fighter Wing had approved the Knife-13 Memorial Project for Luke Air Force Base.

8.10 SAFESIDE LIAISON REPORT: Presented by Jerry Nelson.

The Safeside Reunion at Moody AFB that had been scheduled for April 20 - 24, 2022 was rescheduled to September 12 - 16, 2022 due to COVID. That reunion was subsequently rescheduled again due to COVID in the Valdosta, Georgia area. The Reunion is now scheduled for APRIL 17 thru 20, 2023.



A SAFESIDE Memorial Bench will be dedicated at Moody AFB during the Safeside reunion. The bench is similar to our VSPA and SAFESIDE benches at the Air Force Museum at Wright-Patterson AFB in Dayton, Ohio. VSPA and SAFESIDE members in this room contributed to the new bench.

8.11 SERVICE OFFICER'S REPORT

8.11a JAIME LLERAS sent the following regarding the PACT ACT (although could not be here this year).

As part of the PACT ACT which the President signed in early August, there are two new Agent Orange presumptive conditions added to the list, which can affect you:

- High blood pressure (also called hypertension)
- Monoclonal gammopathy of undetermined significance (MGUS)

MGUS usually causes no problems. But **sometimes it can progress to more-serious diseases, including some forms of blood cancer**. If you have high amounts of this protein in your blood, it's important to have regular checkups so that you can get earlier treatment if it does progress.

If you think you're eligible for VA health care and benefits, we encourage you to apply now.

There added FIVE NEW AGENT ORANGE PRESUMPTIVE LOCATIONS under the PACT ACT.

- Any U.S. or Royal Thai military base in Thailand from January 9, 1962, through June 30, 1976
- Laos from December 1, 1965, through September 30, 1969
- Cambodia at Mimot or Krek, Kampong Cham Province from April 16, 1969, through April 30, 1969
- Guam or American Samoa or in the territorial waters off of Guam or American Samoa from January 9, 1962, through July 30, 1980
- Johnston Atoll or on a ship that called at Johnston Atoll from January 1, 1972, through September 30, 1977

If you served on active duty in any of these locations, the VA will automatically assume (or "presume") that you had exposure to Agent Orange.

The Secretary of the VA said at the recent DAV National Convention in early August, that they are preparing for the thousands of claims submissions as a result of these new additions. The Secretary also said that they won't be ready to begin processing until January 2023, but that Veterans should start filing their claims now.



You should, at the very least, submit an Intent to File From (VA Form 21-0966). This will tell the VA that you plan to submit a claim, but you don't know for what or when. When you submit the Intent to File form, the VA gives you 365 days to submit your claim along with the necessary evidence. If and when they approve, or award compensation for your claim, the pay will be backdated to the date on your Intent to File form.

Many of us have high blood pressure, also known as hypertension, but have never been able to claim it as a disability - now we can and should! That concludes Jaime's report.

8.11b HEALTH SURVEY BY 2nd VICE PRESIDENT DEKE DECUBELLIS

An initial review of the anonymous data submitted by 19 members at this reunion indicates a trend where members have health issues that are presumptive, automatic approvals for Agent Orange related VA Disability Compensation based upon a medical diagnosis. However, they are not receiving VA Compensation. One of those conditions is hypothyroidism. Another is diabetes with neuropathy.

Some members reported Peripheral Neuropathy related to dioxin but not related to diabetes. Other conditions reported were PTSD and Sleep Apnea. A follow-up report will be provided at the next reunion after additional surveys are received and tabulated.

8.12 J.J. CHESTNUT MEMORIAL SCHOLARSHIP COMMITTEE REPORT Presented by Jim Lebowitz. Please encourage your children, grandchildren, and great grandchildren to apply. This year we received two applications that were reviewed by the Scholarship Committee. The applications were all outstanding, the best ever received by the committee and extremely difficult to rate. Therefore, the Scholarship Committee recommends that the J.J. Chestnut Memorial Scholarship of \$1,000 be awarded to both applicants due to their merit.

The recipients are: Madelynn Chi and Evan Elliott.

Chairman Lebowitz reported that committee member Rick Gano will become the chairman of the Scholarship Committee. Jim "Buddha" Lebowitz will remain on the committee. Vice President Larry Fleming will also serve on the committee.

8.13 REUNION REGISTRATIONS: by Jerry Nelson. In 2019, the Reunion BRAT and your VSPA Board of Directors, in accordance with a unanimous vote of the membership, developed an Early Bird discount if members submitted their registrations early, which would allow planning without the severe impact of late registrations. That program was highly successful in 2021 and again this year. We appreciate your effort to comply. We will make certain that the Early Bird Discount is available to members who submit early registrations for all future reunions.

Some of our fellow VSPA members served with me at Hamilton AFB in the last 60s and early 70s with some tours of SEA tucked in and around our time at the Garden Spot of the West. The base was situated on Hwy 101 north of San Francisco and south of the everpopular Napa/Sonoma wine country. The Peace and Love--Drop-in/Drop Out--Flower Children of the Haight-Ashbury era were still roaming Baghdad by the Bay (SE) and Marin Coun

In those days we stood out with our short haircuts, close trimmed mustaches and physical fitness versus those bell-bottomed colorfully clad souls.



The NCO corps of our Air Force had their hands full trying to lead, manage, mentor, and discipline our draft-era youth during that period. As a new troop assigned to Hamilton I quickly learned that the Chief is *always* right. I'll offer one of two true stories.

I had several interesting experiences during my three years of active duty at Hamilton with a year in Vietnam sandwiched in between. The fall of 1969 was one of significant anti-war demonstrations around the country and our airplane patch was a regular target. There was a decent approach to the base main gate off the frontage road which ran parallel to Highway 101. It had a traffic island that the demonstrators would set up on and make their anti-war pitch without interfering with the flow of traffic. Thus, Novato PD and the CHP, which had concurrent jurisdiction, would let them be. Base Security Police, on the other hand, had to be alert to possible infiltrators or other disruptions so we always had riot control training on our "days off", and had an apprehension team on standby should we need to disperse any violators.

On Thanksgiving Night 1969, (all cop leaves were cancelled), I was on graveyard shift at the Main Gate with Sgt Butch Trachtenberg (Thailand vet). Traffic was down to a drizzle like the mist beginning to cover the area. We'd blacked out our interior gate shack lights so as to not be so easily observed by a group of demonstrators still maintaining their vigil out on the just off-base highway island. The center section of our Spanish style four-arch gate structure contained a space heater which was operating that chilly evening. No chairs were allowed in these shacks but a gun-metal grey steel table sat against the opposite wall. One could lean against it and stay warm while maintaining overwatch of the gate approaches. Normally that table contained only the Post Instructions binder, base maps, and other official stuff but tonight it held treasure! The mess hall had baked a bunch of delicious pumpkin pies for the "Holiday", and one of the patrols had just brought us a warm full pie with whipped cream, plates and forks and fresh hot coffee! It now resided in the dark shadows on that table awaiting us to devour it.

We were about to get into this delight when we wisely detected our Squadron Superintendent's vehicle approaching as the LE patrol was departing. The Chief then pulled into the parking lot just inside the gate. Chief (at that time, the 5th ranking time-in-grade E-9 in the Air Force), was indeed a CHIEF in every way, and not an E-9 if you know what I mean. All six-plus feet of this athletic man exuded professionalism as extracted himself





from his 280Z and approached us. We promptly reported our posts and answered the usual obligatory questions. He then stood in the traffic lane eyeballing the hippies up on the main drag. He commented as long as they kept to themselves on this foggy and cool Marin County evening, things would be ok. Chief then entered the center gate house and approached that heater where he warmed his hands a bit as he kept his eyes on the hippies in the distance then without warning, he suddenly backed up onto the table without looking. Due to his height, his buttocks overlapped nearly half of the table, *and* a good piece of our still warm unauthorized pumpkin pie. Butch and I saw what was about to suddenly happen but could not utter a warning a timely warning in time so we remained speechless once it happened. We knew that life as we knew it, was about to end.

Chief maintained his position without flinching for some very, very long seconds and then majestically arose. He stood there for a few more seconds then moved confidently to the exit and turned to face us. I was expecting him to direct the Flight Chief to have us surrender our badges and weapons. We were both holding our breaths while standing at attention. Chief merely said, "Keep up the good work. Happy Thanksgiving. Carry on." He did an about-face and walked briskly back to his car with pieces of pumpkin pie residue clinging to his trousers and occasionally flaking off to the pavement. As he walked away, we turned to face the highway afraid to do anything else. A long minute later, we heard him drive away so we dared to look at each other then burst out into side-splitting laughter. We figured we'd survive this incident so we inspected the pie, decided the back half was still very edible, and consumed it.

The Saga of the Thanksgiving Pumpkin Pie obviously made its way surreptitiously around the squadron but to my knowledge, no one who valued his stripes and his life ever brought it up in the presence of Chief, who is always right, because he is the Chief.

Post-script: this Chief save my butt from the fury of a wanna be pilot butter-bar officer dumped into the SPs on my first duty day as a cop. Chief and I served together at Hamilton on two tours and stayed in touch throughout my rise from a one-striper during my 36-year career. I was honored that he attended my Change of Command and Retirement Ceremony in 2006. He still resides in Sacramento. And yes, I *finally* politely mentioned that Thanksgiving night where he took the time to do post-checks to watch out for his troops. We smiled at each other full well knowing what we both knew about that pie without specifically mentioning it, because even a retired Colonel knows full well that Chief is *ALWAYS* right.
